

## Scholarship Terms, Conditions & Directions

### Application Form

By submitting an application, the applicant gives TNChiroFoundation and/or Tennessee Chiropractic Association consent to use their essay, name and information for marketing and promotional purposes. There are no costs or fees associated with applying for this scholarship. When you have completed the online form, you will receive an email confirming your submission.

**Letter of Recommendation** - In addition to the online application, applicants must submit a letter of recommendation from a professor or academic advisor. This should be submitted to [info@tnchirofoundation.com](mailto:info@tnchirofoundation.com) no later than 11:59 PM EST on June 30, 2024. Please include applicants full name and contact information in the body of the email.

**Proof of Current Cumulative GPA** - In addition to the online application, applicants must submit proof of current cumulative GPA. Printout from school grades report is acceptable. Official transcript not required. This should be submitted to [info@tnchirofoundation.com](mailto:info@tnchirofoundation.com) no later than 11:59 PM EST on June 30, 2024. Please include applicants full name and contact information in the body of the email.

**Submission Deadline:** Application as well as letters of recommendation and proof of GPA must be submitted to [info@tnchirofoundation.com](mailto:info@tnchirofoundation.com) no later than 11:59 PM EST on June 30, 2024 in order for application to be complete.

\*\*\* Any incomplete submissions (missing 1 or more of: application, letter of recommendation or proof of GPA) that are received past the current deadline date will result in the application being considered for the *next* scholarship cycle.

### Scholarship Award Details

Application must be completed in its entirety. All fields are required unless otherwise noted. If any portion of the application is incomplete, you will forfeit your consideration for this scholarship.

Funds will be paid directly to the educational institution and may be applied to any eligible items related to cost of attendance according to your school's financial aid office. These may include tuition, fees, room, board, books, personal/living expenses, and transportation.

The scholarship is for 1 year. Applications are only valid for the scholarship cycle in which they are received. Applicants who do not receive the scholarship are not automatically considered the following year. Receipt of scholarship does not guarantee receipt of future scholarships. Recipients may reapply but will be subject to the requirements for the term for which they are applying.

Scholarship recipients will be notified by July 15, 2024. If you are selected as the scholarship winner or honorable mention, TNChiroFoundation will request a profile photo to be included with your scholarship on our scholarship page and future promotions.



## How We Use Your Personal Information

Your email and/or phone number will be used to contact you concerning the scholarship. We will not provide this information to any 3rd party.

Your name, the name of your school, and your photo may be used if you are selected as a prizewinner, or if you are among our honorable mention candidates.

By submitting your essay, you agree to our terms, namely that the TNChiroFoundation and/or Tennessee Chiropractic Association, may use your essay in future marketing and promotional materials. This is in effect regardless of if you are selected as the scholarship recipient or not. We reserve the right to republish all submitted essays.

## Responsibilities of DC Scholarship Recipients

- Scholarship recipients must attend college on a full-time basis in the fall of the year in which the scholarships are awarded and continue in college that entire academic year. Recipients are responsible for having the TNChiroFoundation notified of their enrollment each quarter or semester by the school. In the event of illness or emergency that makes attendance impossible, recipient must contact TNChiroFoundation immediately. These situations will be handled on a case-by-case basis.
- Recipients must maintain a 3.0 or better cumulative GPA.
- Failure to meet these conditions may result in the forfeiture of the scholarship.

## Essay Requirements

Your essay should be 500-1000 words and should be submitted within the online application form. These questions are designed to elicit comprehensive responses that reveal the applicant's commitment, vision, and preparedness for a career in chiropractic care, as well as their potential fit for our scholarship.

Please choose one of the following topics:

1. Personal Aspirations: Could you describe your personal objectives within the chiropractic field? How do you envision your career path and impact in this area?
2. Motivation and Scholarship Importance: Why are you passionate about pursuing a career as a chiropractor? Additionally, how will this scholarship support your educational and professional journey in chiropractic care?
3. Vision for the Profession: From your perspective, what does the future hold for the chiropractic profession? How do you see the role and practices of chiropractors evolving?
4. Addressing Healthcare Challenges: In your view, what is the most significant challenge facing the American healthcare industry today? How do you believe you can contribute to addressing this issue through your work in chiropractic care?
5. Commitment to Community Health: How do you plan to use your skills in chiropractic care to improve community health and wellness? Can you provide examples of how you've already contributed to health promotion or community service?
